

Which macro-regional strategy are you representing?






Role of Smart Villages in EU macro-regional strategies Do you agree that smart villages/smart communities should have a bigger role than they currently do in EU macro-regional strategies?



# MRS key success

#### **Effective Governance**

EUSALP AG7: an effective governance (multi level one) is the only one that can facilitate a real change

EUSDR PA5: There is a need to improve policies and community engagement in order to have a better governance in order to increase awareness and attract funding for needed infrastructure and change the behavior

# MRS key success

### **Community Engagement**

EUSBSR PA Transport: Engaging communities could bring significant positive impact towards change and awareness of Strategy impact

EUSBSR PA Culture: The success depends heavily on the people involved and their intrinsic motivation as well as on political support and therefore sufficient funding EUSALP AG2: Importance to involve stakeholders in a long-term perspective

### **Strong Policy Frameworks**

EUSALP AG9: Only political frameworks lead to success in smart villages

EUSDR PA10: Political support/will; change of political culture (towards active citizens

participation)
